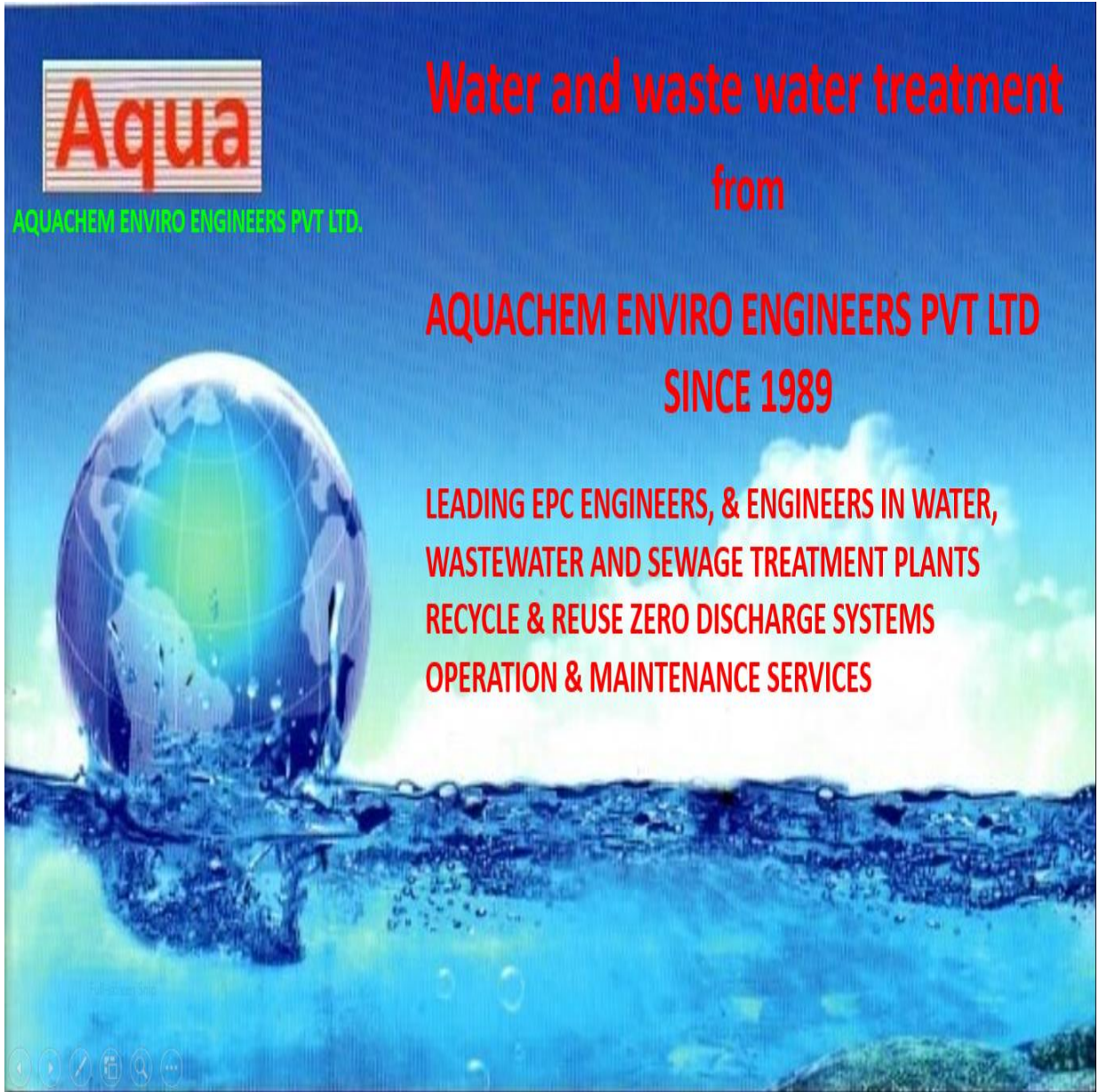

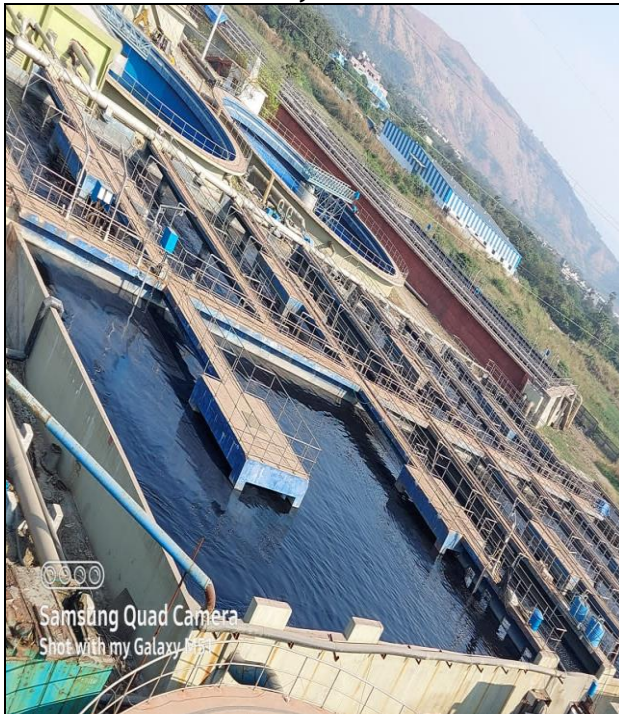

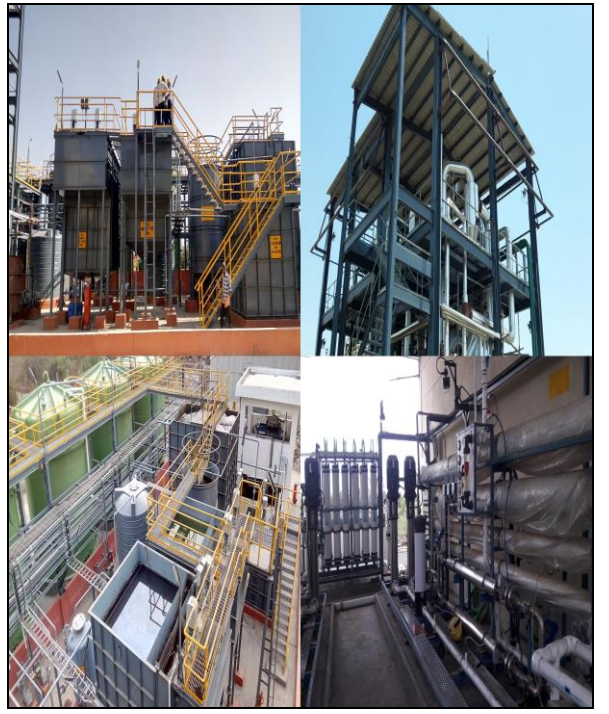
STP Kevadia 2021

2. Equipment Design & Manufacturing:

AQUA has access to manufacturing facility at NAVI Mumbai. This is primarily used for Equipment fabrication and assembling the process components.

This facilities is equipped with fabrication and manufacturing of Wastewater Treatment Equipment like Flash Mixers, Flocculators, Aerators, Diffuser Assemblies, Clarifiers, Polishing, Treatment Filters etc.

It provides excellent synchronizing of task between the designers and builders of the project. The smooth co-ordination between engineer's concepts and workmen's skills assures timely completion of the project. This is ideal happening point for transforming AQUA's design board output into fully functional process equipment that delivers most optimum results to all our customers.

The facility also supports analytical laboratory, training as well as research facilities.





3. Common Effluent Treatment Plants [CETP]:

AEEPL develop CETP projects on PAN India basis. These projects are based in wider industrial estate of prominent states like Maharashtra (MIDC) Gujarat (GIDC) Telangana (TSIIC), West Bengal (WBIDC), Tamil Nadu (TNIDC).



AEEPL has successfully executed 9 CETP projects having capacity range from 0.320 to 55 MLD. Services to CETP Projects are comprising of carrying out Treatability Studies of effluents from member industries, consulting for process design and detail engineering, Project Management Consultancy, Project Execution (on EPC basis), Operation and Maintenance.

Usually Medium and large scale industrial units in an industrial estate do have complete effluent treatment facilities. However, same is not the case with MSME units. Therefore the basic CETP concept is to provide cost – effective treatment facilities for MSME organizations. MSME units have only in-house primary treatment system and the primary treated effluent from their respective units is conveyed to CETP for further treatment and disposal along with treated effluents from large & medium scale units in accordance with the parameters as stipulated by the respective pollution boards.

4. ZLD Projects

Zero liquid discharge (ZLD) is an advanced wastewater treatment method that mainly comprises of Effluent Treatment Plant, ultrafiltration, reverse osmosis, evaporation/crystallization, and partial electrode ionization. ZLD is a water treatment process in which all wastewater is purified and recycled; which leaves zero discharge at the end of the treatment cycle.

Industrial discharge (often from Power / Chemical plants) produce wastewaters that contain salts, coal, leachate etc. Evaporation of those liquid wastes in a modern zero liquid discharge system produces clean water that is recycled into the plant plus a solid product suitable for landfill disposal.

Zero liquid discharge is mainly a process for maximum recovery of water from a waste water source that would otherwise be discharged. This water is beneficially reused and the salts, and other solids contained in the waste water are produced and generally disposed in a landfill.

The necessity of ZLD is due to growing concern by the public about the impact of industrial discharges on the environment and water scarcity. Water a scare vital resource is depleting continually. This growing concern is resulting in increased regulation and limitation of waste water discharges. Many industries in various segments are voluntarily mandating initiatives for reducing water discharge by recycle reuse and ZLD. One of the prominent CSR exercise is to reduce their environmental footprint and improve sustainability.

5. Skid Mounted Units (Water & Sewage Treatment Plants)

PACKAGED Water Treatment plants are emerging as instant treatment alternative for small scale industries having less than 25KLD water consumption.

AQUA has developed ready to use portable Skid Mounted Units for waste water and sewerage treatment of Residential and Commercial Complexes, Hotels, Restaurants, Hospitals, Theaters, Community Halls, Shopping Malls, Religious places, Transport hubs, Sports Clubs, Tourist Spots, CSR Projects like public sanitation, waiting lounge, eateries, Gardens, Walking Parks, drinking water fountains etc.

These Units can be flexible while assembling and can be conveniently custom configured to suit the specific requirement of user industry.

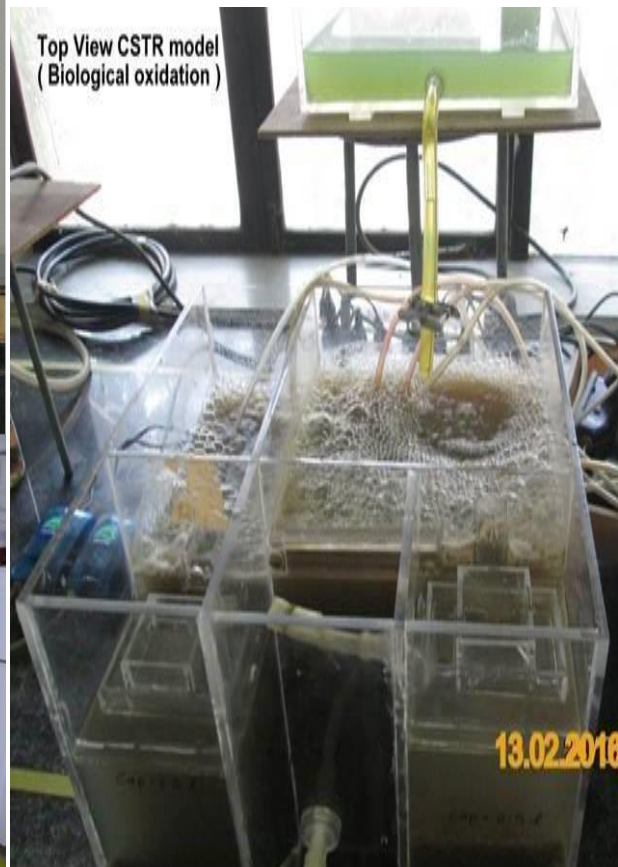
